Cannabis Under Federal Law

- Cannabis is still a Schedule I drug
 - 33 States: Medical Cannabis Program
 - 11 States: Adult Use Cannabis Program
 - 14 States: Access to CBD (limited THC content)

MORE Act

- Would decriminalize & deschedule cannabis
- Passed House Judiciary Committee Nov. 20, 2019

Cannabis Under Federal Law

- Congress enacted the Comprehensive Drug Abuse Prevention and Control Act of 1970
 - 21 U.S.C.A section 801 et seq.
- The act classified controlled substances according to their potential for abuse
- The Act defines offenses involving the manufacture, sale, distribution, and possession with intent to distribute these substances.
- Provision is made for registered practitioners to dispense controlled substances for approved purposes

Federal Updates

- Safe Banking Act
 - H.R. 1595; full title Secure and Fair Enforcement (SAFE)
 - Prohibits federal regulators from punishing financial institutions for the sole reason that they choose to provide such services to cannabis companies, their owners and their employees.
 - A depository institution shall not, under federal law, be liable or subject to forfeiture for providing a loan or other financial services to a legitimate marijuanarelated business.

California Disclosures

- Definition of Owner:
 - Aggregate ownership interest of 20% or more in the applicant, unless the interest is solely a security, lien, or encumbrance,
 - The chief executive officer of a nonprofit or other entity (may be expanded);
 - A member of the board of directors for a nonprofit; or
 - An individual participating in the direction, control, or management of the applicant.
- All "owners" must go through rigorous background check
 - Identifying information (name, title, date, and place of birth; Social Security number or individual taxpayer identification number; government issued identification:

California Disclosures

- When an entity has a financial interest in a commercial cannabis business, then all individuals who are owners of that entity shall be considered financial interest holders of the commercial cannabis business.
- All other financial interests and source of funds in applicant must be disclosed on license application
 - Name of source, amount, and location of all funds available to business even if amount not enough to meet "Owner" definition threshold
 - Investments
 - Gifts
 - Loans
- All other financial interests and source of funds in applicant must be disclosed on license application
- Depending on licensing agency applying to, identifying information such as name, birthdate, driver's license, social security number or EIN may need to be disclosed



State Registration


- Most states allow registration




Celebrity Licensing Challenges
