

MINUTES OF THE LICENSING INTERNATIONAL ANNUAL MEETING

May 26, 2022, 8:30am ET

I. CALL TO ORDER

Maura Reagan, Licensing International President, called the meeting to order.

II. INTRODUCTION OF THE BOARD OF DIRECTORS

III. APPROVAL OF MINUTES OF THE 2021 ANNUAL MEETING

Upon motion made, seconded and carried, the minutes from the June 30, 2021 Annual Meeting were approved.

IV. FINANCIAL REPORT

Financial Summary

Maura Regan reviewed the P&L Summary 2020 versus 2021. We had a substantial loss in 2020, primarily from the lack of Licensing Expo being in person. We cut back on expenses where we could through staff salary reduction and anywhere we could to shave expenses. In 2021, we were able to increase our revenue through events, attendance fees and advertising revenue. Operating expenses decreased by 15%.

V. LICENSING FORWARD

Membership Update:

We just launched a new member benefit, Better Help, a mental health therapy platform, to support our member companies focus on the wellbeing of their employees to ensure productivity and retention. Each employee will be eligible for 4 sessions with a therapist and then ongoing sessions are 15% off. This is a truly global benefit as Better Help has offices around the world speaking many languages.

Maura Regan reviewed our current content focus. Some the of the main topics we are focusing on include the expansion of LBE, NFTs, business cases behind supporting mental health and looking into supply chain and its effects on retail strategy.

Develop Major Partnerships:

Maura Regan described some of the new partnerships the organization has developed. She highlighted the new opportunities we have with Spielwarenmesse. In October 2022, we will have a joint licensing fair in Germany called Licensing X and we are looking at doing a Licensing Day in France in March of next year in conjunction with Informa. We have also solidified a partnership with Products of Change (POC) whereby member organizations can take advantage of a 10% discount on POC
